## DEADLY OBSESSION & DEADLY DIVORCE: THE TRAGIC CASE OF MISSING MOTHER MAYA MILLETE


Maya went missing from her home in Chula Vista on January 7, 2021.

"48 Hours" did a story on the case and I was in the show.

Maya has been missing now for 5 years and her family is desperate to find her. I have gone on the searches and to the court hearings and have gotten to know Maya's family. They are wonderful people with a deep faith in God. They still need the public's help in finding Maya.

Investigation revealed Maya wanted a divorce, but her husband Larry did not want to let her go. Did he kill her in response?

Nine months after Maya went missing, Larry was charged with her murder even though her body had not been found. Larry pled not guilty. His trial is set for May 11<sup>th</sup>



## MAYA & LARRY MILLETE

Maya comes from a large Filipino family. They moved to Hawaii and Maya met Larry when they were both working at McDonalds. They got married very young – Maya was 19 and Larry 18. Larry joined the Navy and they eventually moved to San Diego.

They have 3 beautiful children, buy a nice house in Chula Vista, and they both have good careers. They end up being married for 20 years. It sounds like everything is going great, but it is not.

Maya is not happy and she wants out of the marriage. Larry is desperate to hold onto Maya. He was always controlling, but now he exhibits stalker-like behavior. He tracks her every move. He even puts the daughter's cell phone in her car to track where she is.

This is too much for Maya and she wants a separation. Larry is now desperate and turns to spellcasters.

# LARRY TURNS TO SPELLCASTERS

- For almost 5 months Larry contacts spellcasters daily to purchase spells for Maya. At first the spells are to obey him, to fall back in love with him. When those don't work, he requests spells that are more dark and harmful.
- December 31, 2020 Larry asks for a spell: "Can you hex to have her hurt enough that she will have to depend on me and need my help. She's only nice to me when she needs me or sick. Thanks again. Maybe an accident or broken bone."

# MAYA'S DISAPPEARANCE

- On New Years 2021, Maya announces to her sister that she is going to divorce Larry. On January 7, 2021, Maya contacts a divorce firm and sets an appointment. That is the last phone call she will ever make. She disappears that night.
- What happened to her? A neighbor's camera picks up what sounds like gunshots. Larry is an avid gun collector, but the FBI cannot definitively say those were gunshots.
- The next morning at 5:58 a.m. Larry backs the car towards the garage. Is he loading Maya's body? At 6:45 a.m. he leaves and is gone 11 hours and 21 minutes. He turns off his cell phone. Where did he go?
- He has their 4-year-old son with him. How do you dispose of a body in broad daylight and with a young child with you?
- Larry says he was at work but changes his story and says he was at the beach all day with his son. But it was a cold January day.

There is domestic violence in their relationship. They have a cycle of abuse for 7 years.


